

A Cleaner Anacostia River: Make It Happen by Recycling Used Motor Oil

Did you know?

- One gallon of oil can contaminate one million gallons of water.
- One quart of used oil can create a slick larger than a football field.
- The four quarts of oil it takes to fill your car's engine can form a slick nearly eight acres in size

Oil and grease are considered to be a problem in the mainstem Anacostia River as well as in Hickey Run and Kingman Lake. In waterways, they are detrimental to water quality and dangerous to aquatic plants and wildlife. Fish, oysters, clams, and other wildlife can be smothered by the slick and settling particles of oil and grease. Or they can be killed indirectly by reduced resistance to infection. Bottom-dwelling organisms and submerged grasses are affected by the reduced oxygen and light levels caused by coating of the water surface. In addition to the initial effects, once the oil begins to dissolve, toxics can be released, which further deteriorate water quality and damage aquatic life

Oil enters waterways when it is dumped in storm drains, is dumped on the ground and seeps into ground water, and is spilled on impervious surfaces and becomes a part of storm water run-off. **The only safe and correct way to dispose of used motor oil is to recycle it.**

Where can you recycle used motor oil? Please call before going to a facility to find out specific instructions, regulations, and hours of operation. Do not mix oil with other liquids.
