MISSION

Protect and enhance the waters and related resources of the Potomac River basin through science, regional cooperation, and education.

WATER RESOURCES

- Implement the Potomac Basin Comprehensive Water Resources Plan
 - Develop options for disseminating water information to land use decision makers
 - Build tables of estimated unreported water use by county
 - Develop a plan for a future project to forecast consumptive use for entire basin
 - Plan workshops to identify roles and responsibilities of basin organizations by comp plan challenge area
- Support the Potomac River Basin Drinking Water Source Protection Partnership
- Support regional spill response with time of travel model and emergency notification tools
- Assist Pennsylvania Department of Environmental Protection, and Adams and Franklin Counties, with countylevel Watershed Implementation Plan III

COOPERATIVE WATER SUPPLY OPERATIONS ON THE POTOMAC (CO-OP)

- Conduct annual regional Drought Exercise
- Begin 2020 Water Supply Study
- Produce monthly (Spring-Summer) Water Supply Outlooks
- Continue implementation of options in the 2017
 Washington Metropolitan Water Supply Alternatives study
 - Support steps to augment regional raw water storage to increase system reliability and resiliency
 - Facilitate development of agreements for cooperative use of Loudoun Water resources
 - Partner with the United States Army Corps of Engineers to implement use of Jennings Randolph Reservoir water quality storage for water supply purposes during drought emergencies
- Continue development of tools for drought operations and planning, including the real-time Low Flow Forecast System
- Work with Metropolitan Washington Council of Governments and state agencies to review drought triggers for regional water use restrictions

AQUATIC LIFE

- Produce tools that calculate indicators of ecosystem health for streams, large rivers, and tidal waters
- Improve predictive models of stream and river health
- Support West Virginia Department of Environmental Protection's Cacapon River filamentous algae surveys and better understand the causes and impacts of algal blooms
- Assist the Chesapeake Bay Program in analyzing monitoring data and answering questions about water quality problems

WATER QUALITY IMPROVEMENT


- Support Maryland Department of the Environment's use of the Chesapeake Bay Program's Watershed Model Phase 6 for TMDLs
- Conduct an analysis of Municipal Separate Storm Sewer System data to detect trends in stormwater quality in selected Maryland counties
- Conduct an analysis to detect water quality trends in the Corsica River, MD
- Assist Virginia Department of Environmental Quality with the Accotink Salt Management Strategy
- Continue providing leadership in regional water quality management
- Provide water quality and biological data management for the Chesapeake Bay Program
- Maintain ICPRB's Water Quality Data Inventory
- Continue developing the Data Inventory, Mapping, and Exploration tool to simplify finding and obtaining Potomac water quality data

COMMUNICATIONS AND EDUCATIC




- Enhance Potomacriver.org website and the use of social media as a portal for water-related Potomac basin information

- Conduct outreach and education to schools, citizen groups, and public events


FY2019 BUDGET
